MINUTES

Regular Meeting of the Board of Directors of the Eastern Shore of Virginia Broadband Authority

January 28, 2021

Board members in attendance were: John Reiter, Mike Mason, Charles Kolakowski and Elaine Meil.

ESVBA management participating in the meeting who were in attendance: Robert Bridgham and Leah Hoopes (Secretary)

Members of the public attending were: Andrew Zubko

Ms. Meil called the meeting to order at 2:01 pm.

AGENDA ADOPTION

Mr. Reiter moved to adopt the agenda. Mr. Kolakowski seconded. Motion passed unopposed.

PUBLIC COMMENT

Andrew Zubko: Mr. Zubko is a board member of Captain's Cove and is looking for financial assistance to build out the Cove.

REVIEW OF MINUTES

Mr. Reiter moved to approve the Regular Board meeting minutes from December. Mr. Mason seconded. Motion passed unopposed.

SYSTEM STATUS & BUILD REPORT

1. WiFi Hotspots- There are currently 24 hotspots in service. The Authority built 2 miles down Captain's Cove and the Cove has funded another 2 miles.

Mr. Mason asked how much penetration the hot spots are getting in the trailer parks.

Mr. Bridgham replied that homes within a couple hundred feet

of the hotspot are able to access the internet.

Mr. Mason asked if the Captain's Cove build was strictly aerial.

Mr. Bridgham replied that it was and that almost all of the remaining build will be underground.

Mr. Mason stated that the public WiFi hotspot locations were based on areas with a high density of Accomack County Public School students without internet.

Ms. Meil asked if there were any new hotspots in Northampton County.

Mr. Bridgham replied that there are now hotspots at Ebenezer AME and Bayview Heritage Gardens.

2. Residential Broadband- Mr. Bridgham reported that the Authority has 1352 active residential customers. He stated that there are 56 customers in service in Harborton, 22 in Bobtown, 47 in Church Neck, 47 in Sanford, 2 on Cheapside, 3 on Cobbs Station, 78 in Accomac, 6 in Townsend, 19 in Greenbackville, 46 in Atlantic, 37 in Wattsville/Horntown, 52 in Oak Hall, 69 in Hallwood, 29 in Painter/Quinby, 40 in Eastville, 31 in Nassawadox, 7 in Oyster, 132 in Exmore, 49 in Belle Haven, 41 in Cheriton, 28 in Wachapreague, 232 in Onancock, 169 in Cape Charles, 76 in Parksley, 5 in Nocks Landing, 27 in Saxis, and 2 on Chincoteague.

Mr. Bridgham stated that the number of homes are based off of where the Authority was 3 years ago

- 3. WISP EVPL Program- Mr. Bridgham informed the BOD that 56 sites are in service, 8 new sites on-order and underway.
- 4. Microcommunity Program- There are 8 communities that are in service and 11 others that are in various stages of progress.
- 5. CARES projects in Accomack & Northampton- Both Accomack & Northampton Counties have additional CARES Act funding that was supposed to expire on 12/30/2020 but has been extended until 12/31/2021. This has created an opportunity for the Counties to consider funding additional broadband projects in the two counties and have asked the ESVBA to provide some projects that would fit the needs of the CARES funding. Mr. Bridgham has provided each county a simple presentation of failed microcommunities, network extensions, and target areas outlining the fiber length, the construction costs and the number of homes that the extension would enable. He also proposed that the

Counties consider using some of the funding to help offset customers that have cost-prohibitive installation fees due to construction costs. The Counties could also consider offering a discount off of the ESVBA installation to households that meet certain income thresholds to help increase the availability for low-income families.

Mr. Reiter asked when are the counties are expected to have answers. Mr. Mason stated that they are going to present a plan to the board of

supervisors at the February meeting.

OLD BUSINESS.

a. Approve FY20 Final Audit- Mr. Bridgham presented the Audit to the Board.

Mr. Bridgham stated that the last paragraph on page 5 is a mistake.

Mr. Mason asked if the Authority received a Management Letter.

Mr. Bridgham stated that they received a Management Letter with the last Audit but have not received one yet.

Ms. Meil asked about the "bad debt" and how the Authority plans to proceed with it.

Mr. Bridgham replied that he has been working on a Collections Policy that he will present to the board when it's completed.

Ms. Meil suggested making a note in the Audit that the last payment for the ANEC loan has been made.

Mr. Mason moved to accept the FY20 Audit. Mr. Reiter seconded. Motion passed unopposed.

b. Address contractor complaint- This item is being tabled.

NEW BUSINESS.

a. **Circuit/Capacity Rehoming -** Mr. Reiter asked what the current cost is.

Mr. Bridgham explained that the typical rehoming fee is \$100 unless there is extensive engineering.

Mr. Bridgham also stated that the only downside is administrative.

b. **Member selection for compensation committee –** Ms. Meil appointed Mr. Reiter to the committee.

c. **Captains Cove Buildout-** Mr. Bridgham presented the map to the board.

Mr. Reiter asked how many customers the map represents.

Mr. Bridgham stated that the map represents about 1000 potential residents, with 350 committed subscribers.

Mr. Mason asked if the Authority needs permission from anyone to start the construction process in Captain's Cove.

Mr. Bridgham stated that they would need permission from the HOA and the home owners.

Mr. Bridgham also explained to the board that Captain's Cove would like to complete the project in phases.

Mr. Mason encouraged the Authority to look into different grant options to help fund the project.

Shannon Wright is a committee member for Captain's Cove and spoke about the individuals seeking service and the need for broadband. She clarified that there are now about 400 committed subscribers.

Mr. Mason asked for a rough estimate if engineering was done in house.

Mr. Bridgham explained that it would be around \$65k and would take about a month to complete.

Ms. Meil asked if the Authority has funds to cover the costs.

Mr. Bridgham stated that the Micro Community fund has almost been expended and the board will be discussing what to do with the remaining funds from the bond in the February meeting.

Mr. Bridgham would like to present the cost estimates to the board at the February Meeting.

The board agreed to add this item to the Work Session in February.

TREASURER'S REPORT

Ms. Meil asked if the decline in cash is because of the Bond buildout and if that will level out soon.

Mr. Mason explained that bond proceeds are still being spent.

BOARD COMMENT

Mr. Reiter would like to Congratulate the Authority on reaching the 6 figure income for residential services.

Mr. Mason thanked Mr. Bridgham and the staff for the assistance in setting up all the public WiFi hotspots in a timely manner.

MINUTES

Work Session Meeting of the Board of Directors of the Eastern Shore of Virginia Broadband Authority

February 25, 2021

Board members in attendance were: John Reiter, Kelvin Pettit, Elaine Meil, Charles Kolakowski, and Mike Mason

ESVBA management participating in the meeting who were in attendance: Robert Bridgham and Leah Hoopes (Secretary)

Members of the public attending were:

Mr. Meil called the meeting to order at 2:05 pm.

AGENDA ADOPTION

Mr. Reiter moved to amend the agenda to add 5b for "Hookups". After discussion, Mr. Mason seconded. Motion passed unopposed.

OLD BUSINESS.

- a. Rate Hearing- There is no public comment
 Mr. Mason motioned to close the Public Hearing. Mr. Reiter
 seconded. Motion passed unopposed.
 Mr. Reiter motioned to adopt the rates as advertised. Mr. Mason
 seconded. Motion passed unopposed.
- **b. Staff Salary Budget-** Mr. Bridgham explained that the FY21 budget included a 3% raise for employees, which was not approved previously.

Mr. Mason supports the initiative since the Authority has substantially increased the number of residential hookups, public WiFi hotspots, and miles built.

Mr. Reiter moved to authorize approval of staff salary budget.

Mr. Mason seconded. Motion passed unopposed.

NEW BUSINESS

a. FY21 budget amendments- Mr. Bridgham presented the budget amendments to the board. Mr. Reiter asked if item 3 covers internal engineering or engineering that has already been completed.

Mr. Bridgham replied that the amount is based off of the ESVBA completing the engineering internally and it would take about a month and a half to complete.

Mr. Mason explained that the Authority can complete the engineering but can't go much further without a grant or additional funds.

Mr. Kolakowski motioned to approve the budget amendments. Mr. Mason seconded. Motion passed unopposed.

b. Consider authorization to enter into agreements with counties for county-funded projects-

Mr. Reiter asked if the funding has a completion dead line.

Mr. Bridgham replied that there is no date set.

Mr. Kolakowski stated that it has to be completed by the end of the year for Northampton County.

Mr. Mason stated that Accomack does not have a dead line.

Mr. Reiter asked if the Authority can complete the Northampton portion by the end of the year.

Mr. Bridgham replied yes.

Ms. Meil asked how much underground is involved in the Northampton County project.

Mr. Bridgham estimated a total of about 5 miles of underground for Northampton.

Mr. Reiter moved to authorize Robert Bridgham to enter into Memorandums of Understanding with the counties regarding building the projects that they requested. Mr. Pettit seconded. Motion passed unopposed.

WORK SESSION

a. Discuss remaining funds from bond proceeds- Mr. Bridgham suggested authorizing some of the additional segments.

Mr. Kolakowski asked if any of the projects line up with the ones that are already authorized.

Mr. Bridgham explained that the segments are aerial and aerial deployments are easier to complete.

Mr. Mason asked if the total cost of the sections would utilize all of the remaining funds.

Mr. Bridgham replied that with the engineering, it would be very close.

Ms. Meil asked if any other broadband authorities are getting geared up to apply for VATI grants.

Mr. Bridgham stated that Roanoke Valley will be applying and a couple others are interested. There will be a call with all the authorities in March. Ms. Meil explained that they should have some answers on what would happen with Virginia's budget before they might get spent funds that they would need later on.

Mr. Mason motioned that the discussion gets tabled until the next meeting. Mr. Kolakowski seconded. After discussion, motion passed unopposed.

b. Hookups- Mr. Reiter stated that as of today, it will take about 3 years to reach the expected 30% of hookups.

Mr. Bridgham explained that the underground jobs have held most of the installs up but more customers are requesting aerial. The authority now has underground contractors and there will be a future IFB that will be split up into sections that contractors can bid on.

Mr. Reiter asked about the Authority doubling its capacity.

BOARD COMMENT

Mr. Mason asked for an update on Tangier.

Mr. Bridgham stated that they received the Tower Agreement and payment has been made for the installation of the cabinet. He estimates that sometime in March the ESVBA will start to place cable.

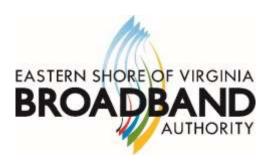
Mr. Reiter proposed that the board have a Work Session in April to discuss getting broadband to the remainder of the shore.

WISP EVPL Program

- Fifty-two (52) sites in service, eight (8) new sites on-order and underway (one has been on hold for quite some time).
- Bandwidth upgrades have been provisioned for several towers and sites continue to be added.
- We are also still processing several migrations from the WISPs on the Eastern Shore

Microcommunity Program

- There now 9 microcommunities in-service and operational (Wise Street has just been finished)
- We have 10 approved microcommunities representing 87-homes that have been approved and are in-progress of being constructed. Sand Hill, representing 27 homes has 80% of the backbone buried.

2021 CARES projects in Accomack & Northampton

The ESVBA has worked with both Accomack & Northampton to prepare MOUs for construction of projects in both Counties. The Accomack MOU was executed 3/19 and Northampton's should be completed shortly. We have started preliminary ride-outs to verify routes are not already built and we have submitted several routes to engineering for design. Materials have started to be ordered to prepare for the builds.

RESOLUTION SMALL PURCHASE PROCEDURES

WHEREAS, pursuant to the authority provided by §§ 2.2-4303(G) of the Code of Virginia, the Eastern Shore of Virginia Broadband Authority ("the Authority") has determined to adopt certain procedures to be followed in procuring goods and services, in order to simplify the procurement process while providing for competition whenever practicable;

NOW THEREFORE, BE IT HEREBY RESOLVED, that pursuant to the above-referenced statutory authority, the Authority, or the Chairperson, acting as purchasing agent, may enter into any single or term contracts for goods and services other than professional services and non-transportation related construction, if the aggregate or the sum of all phases is not expected to exceed \$200,000.00, without competitive sealed bids or competitive negotiation as provided by the Virginia Public Procurement Act (§2.2-4300 et seq. of the Code of Virginia).

BE IT HEREBY FURTHER RESOLVED, that, pursuant to the above-referenced statutory authority, the Authority, or the Chairperson acting as purchasing agent, may enter into single or term contracts for professional services in an amount not expected to exceed \$80,000.00, without competitive sealed bidding or competitive negotiation.

Cancellation, porting and collection policy Eastern Shore of Virginia Broadband Authority Draft v1.01



Cancellation & Service Portability:

From time to time, customers of the network may wish to cancel or move their service and require clear guidelines regarding said cancellations. A cancellation is a customer-requested termination of service either prior-to the service activation or during the term of the service. The standard termination of service during the term of the contract is explicitly declared in the users service agreement. This policy is to augment the standard language with clarifications and exceptions.

For cancellations prior to the activation of service-

Users may have ordered service prior to the activation of service and then they may request that the ordered service be cancelled for several reasons. The policy is set as follows:

- If the ESVBA has completed no work nor incurred any expenses by the time the customer has requested to cancel their order, the ESVBA will refund the customer any installation fee that had previously been paid. The service will be considered canceled and the customer shall incur no further fees/charges.
- If the ESVBA has completed some work but not activated the service to the
 customer, the ESVBA will retain any fees collected and may send a further bill to the
 customer that includes any incurred costs that have been incurred above and
 beyond the original installation fee.
- The ESVBA reserves the right to place a lien upon the real estate for the amount of any fees other charges by an authority to the owner or lessee or tenant of the real estate for the use and services of any system of the authority by or in connection with the real estate from the time when the fees, rents or charges are due, and for the interest which may accrue thereon.

For cancellations upon and beyond activation of service-

It is the policy of the ESVBA that once a customer has received service, they are responsible for their installation fee and monthly fees throughout full original service term or full automatic renewal term. If a customer notified the ESVBA in writing with their intent to cancel service upon completion of their original term or completion of a renewal term, within the timeframe outlined in their MSA or Customer Service Agreement, the customer will receive their last bill during the last month of service. The customer is responsible to return or make available access to return any ESVBA-provided equipment and electronics. Upon payment in full of the final bill, and satisfaction of the ESVBA recovering any equipment electronics it provide, the contract will be considered satisfied and there will be no further obligation of the customer nor the ESVBA. There is no adjustment, offset, or reduction of the remaining monthly fees during the term of the contract except the following:

• If a customer is vacating a property and a new customer is going to be assuming a new contract at the same property where the previous customer vacated, and the contract value and monthly billing of the new customer is greater to or equal to the

remaining contract value and monthly billing of the vacating customer's remaining contract value then the original customer will be relieved of their responsibility to complete their contract past when the new customer's service is active **The original customer is still 100% responsible for any and all charges incurred up-to the time that the new customer has accepted service.**

- If an existing customer is moving from their on-net address to another on-net address, and the new address has no previous customer encumbrances or open contracts, the customer must start a new term at the new location that includes a contract value that is greater to or equal to the remaining contract value of the original address.
- If an existing customer (Customer A) is moving from their on-net address to another on-net address, and the new address has an existing customer (Customer B) that is looking to cancel their service, the original customer (Customer B) that is vacating the new address is still responsible for the remainder of the fees of their contracted terms stated in their customer agreement or MSA. The customer moving into the new location (Customer A) must start a new term at the new location that includes a contract value that is greater than or equal to the remaining contract value of the original address.

For requests to port the service-

A customer that wishes to either move their service or to change existing services to better utilize the ESVBA network will be permitted to make said change requests with the following restrictions:

- All residential service port requests will require an administrative fee of \$100 to rehome their deliver from the previous location to the new location. Each service change will each incur this administrative fee.
- All commercial service port requests will require an administrative fee of \$175 to rehome or rearrange any single individual service. Each service change will each incur this administrative fee.
- The customer may request that service be maintained in the previous location and be available at the new location simultaneously for a period of no more than 5-days when possible. Requests to maintain dual-services past 5-days will require the customer to pay the monthly fee at each location for dual-services for a full-months usage. At no time will dual-services be allowed beyond 30-days.
- If the new location requires any costs to move the service to, the customer will be billed an installation fee of the total costs to prepare the new location for delivery of the ported/rehomed service.
- The contract value and monthly billing, at the new location, must be equal to or greater than the contract value and monthly billing of the service site being reduced or moved from.
- For customers that want to alter their bandwidth subscriptions to decrease service in one location and increase in another must ensure the total contract value and monthly billing combined for the two locations must be equal to or greater than the

contract value and monthly billing of the original services. The customer may also be billed an installation fee that includes the total costs to prepare the new location for delivery of the ported/rehomed service.

Collections:

The ESVBA will use a uniform method of billing and collections to ensure a balanced and consistent approach to the collection of fees for services provided by the ESVBA.

The ESVBA issues a bill to a customer for any installation fees as a stand-alone bill which is typically due within 30-days of receipt of bill (NET-30); other terms maybe applicable based upon the individual customer agreement. Collection terms may be adjusted depending on the customer's debt risk and past history with the ESVBA including, and up to, the possibility of requiring a deposit that may be three times the monthly billing of the customer; this is by discretion of the ESVBA billing department.

The ESVBA issues a service bill upon delivery of the service, as per the user agreement, and the first bill shall include any partial service for the remainder of the then current month as well as the full months billing of the next calendar month. Payments are due withing 30-days (NET-30) by default unless terms are changed by the ESVBA billing department.

For customers that become delinquent in their billing the following standards shall be adhered to:

- For any balance that exceeds the standard 30-days terms (or the terms established by the ESVBA billing department), the customer shall be notified in writing, via e-mail, and/or via a phone call that they have gone past their agreed upon billing terms and are in arrears. This shall be annotated in their account in the ESVBA Customer Relations Management (CRM) software. The customer shall be requested to make a prompt payment to bring the account in good standing or make arrangements with the ESVBA billing department for their past-due. The customer shall be strongly encouraged to keep their current bill up to date so they do not fall further behind. Customers are subject to a late fee as designated in their customer agreement or MSA.
- If a customer has not paid their past-due within 15-days of the first notice of delinquency, a second notice via at least two of the three aforementioned methods will be used and documented within the ESVBA CRM. Additionally, the customer will be warned that if they have not made arrangements that the ESVBA has agreed to, their service is subject to disconnection as well as a reconnection actions and fees. The ESVBA may also assess late fees based upon the contract terms which will be due within 30-days as well. The customer will also be notified that any past-due amounts can be filed as a lien with the County the property is located in. The customer will have the ability to stay these additional actions of disconnection and fees upon mutually agreeable arrangements with the billing department including payment in full.

- If a customer has not paid their past-due within 15-days of the second notice of delinquency, a third notice via the three aforementioned methods will be used as well as notice via registered mail that service will be disconnected within 5-business days of the receipt of the registered mail. All notice information shall be documented within the ESVBA CRM. The ESVBA will also assess late fees based upon the contract terms which will be due within 30-days as well. The customer will have the ability to stay these additional actions of disconnection and fees upon mutually agreeable arrangements with the billing department.
- If upon the expiration of the 5-business days from the third notice, the customers service will be disconnected, the customer will be notified of the disconnection and their continued responsibility of the contract through the completion of the term, the fact that the late fees as well as remaining service fees will also be filed with the county as a lein against the property. The customer will be required to pay their past due as well as any late fees and disconnect fees prior to having their service restored. If the user elects to discontinue their service either by an affirmative response or by a lack in response, the ESVBA will assess the remaining monthly fees through the remainder of the term as a single disconnect fee which shall be notified to the customer in writing. This disconnect fee shall follow the same steps as above excluding the disconnect efforts (as the service is already disconnected).

A user who has not satisfied their previous ESVBA financial obligations shall be denied access to ESVBA services until all previous debts are satisfied. A deposit before securing service again maybe required.
